<b>Professional Business Woman</b>	\$3,000 (\$250 per month*)	Full golf, pool, dining & social privileges
<b>Second Club</b>	\$2,900 (\$241.66 per month*)	Full golf, pool, dining & social privileges. (must be a current active member of Bellevue Country Club, Cavalry Club, Onondaga Golf and Country Club, or Skaneateles Country Club)
<b>Corporate Limited</b>	\$6,000 (\$500 per month*)	4 corporate members includes Monday-Friday golf. Weekend golf incurs a guest fee. Full pool, dining & social privileges (Cannot participate in any member tournament or league)
<b>Corporate Preferred</b>	\$8,000 (\$666.67 per month*)	1 full golf membership and 3 corporate members. Preferred member has no restrictions. 3 corporate members earn Monday-Friday golf. Weekend golf incurs a guest fee. Full pool, dining & social privileges included for all 4 members. (Preferred member can play in all member tournaments. 3 corporate members are restricted from play in any member event)
<b>Student (Full-Time)</b>	\$1,000	Full golf, pool, dining & social privileges
<b>Harbor</b>	\$2,500	Full harbor, pool, and dining privileges. Members must pay Harbor Fee and Dockage Fee of \$2.25 per square foot, with a minimum fee of \$750 per year for dockage costs
<b>Pool and Social</b>	\$1,000	Full pool, dining & social privileges
<b>Dining</b>	\$550	Full dining privileges

**Special Note:** Harbor may be added to Full Golf Membership by paying a Dockage Fee of \$2.25/square foot, with a minimum fee of \$750 per year.

All member categories and member dues noted above are for the 2018/2019 Fiscal Year which runs from April 1, 2018 to March 31, 2019 and are subject to a food and beverage minimum of \$125 per month from April 2018 thru November 2018.

# MEMBER'S CONTRACTUAL AGREEMENT

---

I understand and agree that as an express condition of my association in Lake Shore Yacht & Country Club (LSYCC), I assume responsibility for the payment of any and all applicable initiation fees, full fiscal years dues (fiscal year is from April 1<sup>st</sup> to March 31<sup>st</sup>), assessments, pool, harbor, clubhouse and pro shop charges, food and beverage minimums, and any other fees or charges as outlined in the Club Rules and Regulations. My membership will continue on a yearly basis thereafter unless I notify LSYCC in writing thirty (30) days prior to the start of any given membership year.

LSYCC is a privately-owned club. I further understand and agree that I am subject to the Rules and Regulations established by the LSYCC and that I accept all provisions, thereof, as part of the terms and conditions of this membership contract. LSYCC reserves the right to alter, modify and/or change the Regulations from time to time.

LSYCC may, at its sole discretion, allow for early termination of this membership agreement only for cases deemed by LSYCC as being due to relocation for employment or for serious medical conditions.

I understand that any overdue balances on my account are subject to interest at the rate of 2% per month, 24% per annum and the collection of reasonable attorney's fees, court costs and costs and disbursements associated with collection and enforcement. I also agree to be primarily responsible and liable for my conduct and that of my guests, family members, and agree to indemnify, hold harmless, agree to defend LSYCC, its members, directors, owners, employees and representatives harmless from any and all actual damages. This paragraph shall survive this Agreement.

Member account charges are due and payable by the 15<sup>th</sup> of the following month. I agree to provide LSYCC with a valid credit card number and authorize LSYCC to charge this card for all dues, fees, installments and charges that are not paid by the 15<sup>th</sup> day of the month that such bill is received for charges from the preceding month. In the event a payment is received by the Club after the 15<sup>th</sup> of the month and the credit card has already been charged for such outstanding charges, such additional payment will be posted as a credit to the member's account to be applied against future expenditures. In the event that the member credit card on file is invalid, all club privileges shall be suspended until such account is satisfied. Members whose accounts are in arrears shall be posted and denied all club privileged until all charges are paid.

I further understand, that as a LSYCC Member, a default by me in the payment of any monetary obligation or termination of my membership, shall result in acceleration of balances due including but not limited to any initiation fees or club dues and any fees and costs incurred by LSYCC in recovering same including legal fees and court costs and disbursements, as well as any other charges outstanding on my account, as determined by LSYCC in its sole and absolute discretion.
