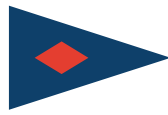

MEMBER'S CONTRACTUAL AGREEMENT

I understand and agree that as an express condition of my association in Lakeshore Yacht & Country Club (LYCC), I assume responsibility for the payment of any and all applicable initiation fees, full calendar years' dues, pool, harbor, clubhouse and pro shop charges, food and beverage minimums, and any other fees or charges as outlined in the Club Rules and Regulations. My membership will continue on an annual basis thereafter unless I notify LYCC in writing thirty (30) days prior to the start of any given membership year.

LYCC is a privately owned club. I further understand and agree that I am subject to the Rules and Regulations established by the LYCC and that I accept all provisions, thereof, as part of the terms and conditions of this membership contract. LYCC reserves the right to alter, modify and/or change the Regulations from time to time.

LYCC may, at its sole discretion, allow for early termination of this membership agreement due to relocation for employment or for serious medical conditions.

I understand that any overdue balances on my account are subject to interest at the rate of 1.5% per month and the collection of reasonable attorney's fees, court costs and costs and disbursements associated with collection and enforcement. I also agree to be primarily responsible and liable for my conduct and that of my guests, family members, and agree to indemnify, hold harmless, agree to defend LYCC, its members, directors, owners, employees and representatives harmless from any and all actual damages. This paragraph shall survive this Agreement.

Please note that if you have a credit card on file to pay your monthly statement, your card will be charged the outstanding balance between the 7th and the 10th of the month. If you do not have an automatic payment established, your balance is due by the last day of the month. If not received by the last day of the month, a 1.5% late fee will be applied to the outstanding balance. Members whose accounts are in arrears shall be posted and denied all club privileges until all charges are paid.

I further understand, that as a LYCC Member, a default by me in the payment of any monetary obligation or termination of my membership, shall result in acceleration of balances due including but not limited to any initiation fees or club dues and any fees and costs incurred by LYCC in recovering same including legal fees and court costs and disbursements, as well as any other charges outstanding on my account, as determined by LYCC in its sole and absolute discretion.
